About Think Ahead Alexandria

With the intention of creating enduring and sustainable support for our nonprofit partners and the constituents they serve; Think Ahead Alexandria is a community-wide effort to inspire meaningful contributions to nonprofits across the city. Like Spring2ACTion, Think Ahead Alexandria is a platform that facilitates giving to Alexandria's nonprofits. A cohort of nonprofit partners will engage their donor bases in

conversations around legacy giving and ACT will support them with strategy support, resources, and tools.

What is Legacy Giving?

Legacy giving is the practice of creating a meaningful philanthropic legacy by designating a significant gift to a charitable organization during life or through an estate plan. Some planned gifts provide life-long income to the donor. Other gift plans use estate and tax planning to provide for beneficiaries (nonprofits or family) in ways that maximize the gift and/or minimize its impact on the donor's estate. These can be gifts of equity, life insurance, real estate, personal property, or cash.

Benefits

For Donors

- Legacy gifts can become part of a donor's life story, ensuring their generosity and commitment to your cause are remembered beyond their lifetime.
- Legacy gifts can help donors "age well" as they find a new sense of pride and purpose later in life.
- Legacy gifts often offer donors the opportunity to leave a major gift that they may not have been able to make in their lifetime.
- Depending on the type of gift, legacy gifts offer several tax benefits to the donor.
- Many types of legacy gifts are possible for people at different ages and in different stages of life.

For Organizations

- Legacy gifts add a new revenue stream with a high ROI (return on investment).
- Legacy giving offers the opportunity to broaden your donors base, attracting individuals who want to do more than write a check to your organization.
- Legacy gifts open the door to deeper connections with your donors, as you really get to know them, their interests, and passions.

Starting the Conversation About Legacy Giving with Your Donors

First, consider the impact. Make sure you can answer the question: *How will a legacy gift impact the future of your organization?* Think about the stability and sustainability a gift of this size would provide and how it could impact your long-term goals (such as the ability to create a new program, expand your reach, start an endowment, etc.)

Take baby steps. Asking a person for a legacy gift shouldn't be the first conversation you have with a donor. Get to know them, their interests, and why they choose to support your cause. Listen for clues so you know how and when to make the ask.

Avoid talking about death. Typically, organizations will not receive a legacy gift until a person passes away, but most people don't like thinking or talking about death. This can make a donor uncomfortable and avoid the conversation. Instead, focus their attention on "creating a legacy" (rather than "leaving a legacy") by supporting the cause most important to them.

Sample questions to get your donors talking:

- What first drew you to our organization?
- What inspires you most about giving? What inspires you most about giving to our organization?
- What do you consider most significant about the work we're doing?
- What keeps you awake at night? How would you like to make a difference in our community?
- Where do you see our organization in 50 years?
- If you could change one thing about [something specific related to your cause, mission or those you serve], what would it be?
- If there were no limits, what would you like to do with your giving?
- If you were to make a significant gift, is there a particular area or program you'd want your gift to support?

Other things to think about....

- **Program promotion.** Many legacy giving programs have a special name, such as [Name] Giving Society or [Name] Legacy Circle. *Will your legacy program have a special name?*
- **Donor recognition.** Some planned giving programs offer donors special benefits. *Will your program recognize legacy donors in a special way?* (Examples: in annual reports, on your website, etc.)
